DISTANCE FIRED: 50 feet 3-Position and 10 meters Air Rifle

TARGETS: Orion Shooting Systems USAS/NRA 50 ft. target, AR-5/10

SIGHTS: 3P Open Sights AR-Metallic Sights

RULES: Current NRA Smallbore Rules. ORION SCORING SYSTEM WILL BE USED.

CHALLENGES: A challenge fee of \$1.00 will be charged for each challenge made.

CATEGORIES: All competitors will be entered in the Collegiate Category with their entry fee. Categories recognized with additional fee are: Junior and Woman.

CLASSIFICATION: All competitors will compete for open awards only unless additional entry for a category has been made. Classifications will not be separated for awards.

ENTRIES: Open to all competitors. **Entry can be made by email or phone call to Mike O'Connor at elevdog@gmail.com or 517-612-9321. Payment can be made at the match prior to any firing, cash or personal check/institutional check may be used. Sorry no credit/debit cards accepted for this match.**

ENTRIES LIMITED: Entries are limited to 12 competitors for each relay which is the capacity of the range within the allotted time.

ENTRIES CLOSE: Match entries must be received no later 5:00 p.m. Tuesday, Nov. 29, 2022.

SIGHTING SHOTS: Unlimited sighting shots will be allowed in all matches and must be taken within the time limit.

SQUADDING: Will be assigned by the Statistical Office.
